## Horse Protection Act Update

This post addresses the Horse Protection Act (HPA) in regard to the WA State 4-H Horse Program.

In short, the HPA is a federal law enacted in 1970 that seeks to address an animal welfare concern by prohibiting sored\* horses from traveling to or participating in shows, exhibitions, sales or auctions. This is an important act. Soring is a cruel and inhumane practice used to accentuate a horse's gait. It is traditionally associated with gaited horse breeds, such as the Tennessee Walking Horse. A higher saturation of the breeds traditionally affected along with horse shows, sales and auctions tailored for these breeds are more common in other states, however, the potential for inhumane practice remains anywhere.

Therefore, recent revisions to the HPA included increased inspection and reporting requirements that were expanded to include all breeds and events (with some exceptions). The revised requirements were scheduled to come into effect on February 1, 2025, however, ambiguity within the revisions has sparked many questions and concerns throughout the equine community nationwide, resulting in a postponement of the effective date to April 2, 2025.

The Animal and Plant Health Inspection Service (APHIS) is the division of the USDA that oversees the HPA.

According to the [APHIS website](#), APHIS will issue guidance to stakeholders for the upcoming horse show season in light of the postponement of the new rule.

As of February 18, 2025, guidance has not yet been posted. At this time, no action is required.

We realize there is a lot of confusion and concern regarding the HPA's potential impact on 4-H and the process for meeting the requirements of this new rule. The WA State 4-H Equine Committee and State 4-H Office have been and will continue to monitor developments. As details become more concrete, we will communicate via Tuesday News and extension listserv email to inform our 4-H community of any steps necessary for 4-H to be in compliance. Again, at this time, no action is required.
