**AMENDMENT NO. 1 TO
INTERAGENCY AGREEMENT
BETWEEN
EASTERN WASHINGTON UNIVERSITY
AND
WASHINGTON STATE UNIVERSITY
July 1, 2020 – June 30, 2021**

14 This Amendment No. 1 (“Amendment No. 1”) herein modifies and amends the Interagency Agreement
15 (the “Agreement”) dated July 1, 2020 between Eastern Washington University, an institution of higher
16 education and agency of the State of Washington (“EWU”) and Washington State University, an
17 institution of higher education and agency of the State of Washington, by and through its WSU Spokane
18 Campus (“WSU”) pertaining to use of the SAC library on the WSU Spokane Campus, as follows:
19

20 (1) A new subsection D. is herein added to Section IV. (EWU Roles and Responsibilities) of the
21 Agreement, which reads as follows:

22 D. For the period of July 1, 2020 through June 30, 2021, EWU will provide a classified
23 staff employee in the SAC library located at the WSU Spokane Campus to assist with
24 provision of services in the library. This employee is employed by EWU and any services
25 performed must comply with EWU’s applicable collective bargaining agreement
26 requirements and policies.

28 (2) Section VI. (Payments & Billing Procedures) is herein modified to reflect that EWU’s Annual
29 Payment to WSU for FY21 (07/1/20 – 06/30/21) shall be reduced from \$253,826 to \$187,391 in
30 consideration of EWU providing an employee in the SAC library as provided in Section (1) above.
31 EWU’s Annual Payment for FY22 shall revert to the amount specified in Section VI.B. of the
32 Agreement (\$258,903), unless the Parties otherwise agree in a written amendment to the Agreement.
33

34 (3) All other terms and conditions of the Agreement remain in full force and effect. All capitalized terms
35 not otherwise defined herein shall have the same meaning as set forth in the Agreement. This
36 Amendment No. 1 may be executed in two or more counterparts, and by electronic signature
37 including scanned copies, all of which when taken together, shall constitute one original document


