For 2026, United has streamlined the verification process. If you have a SkyMiles account and your name there doesn't match your ID, you typically have a one-time opportunity to update it online. However, for an existing flight booking, you must call ☎+1⇒888⇒217⇒7407 (US) to ensure the change is reflected on the actual ticket.

Accepted documents for a legal name change include a marriage certificate, divorce decree, or a government-issued court order.
