History of Tests for Temperature-adjusted Wood Stove Emissions

- 2010: Simple $(T/HDD > T/HDHr) \times HDH_{(20-50)}$
 - Over-estimated emissions in AP3

- 2013: $(T/HDD > T/HDHr) \times HDH_{(20-50)} \times f(MoY) \times f(DoW) \times f(HoD, DoW)$
 - Over-estimated emissions in AP3 – so revisit for AP4 with re-normalized factors?

- 2013 – reviewed SMOKE GenTPRO; for retro runs!

- 2014a – $(T/HDHr) \times HDH_{(20-50)} \times f(MoY) \times f(DoW) \times f(HoD, DoW)$
 - Found minor emission inventory errors to correct.
 - Over-estimated emissions in AP4 – so redo without MoY factor.

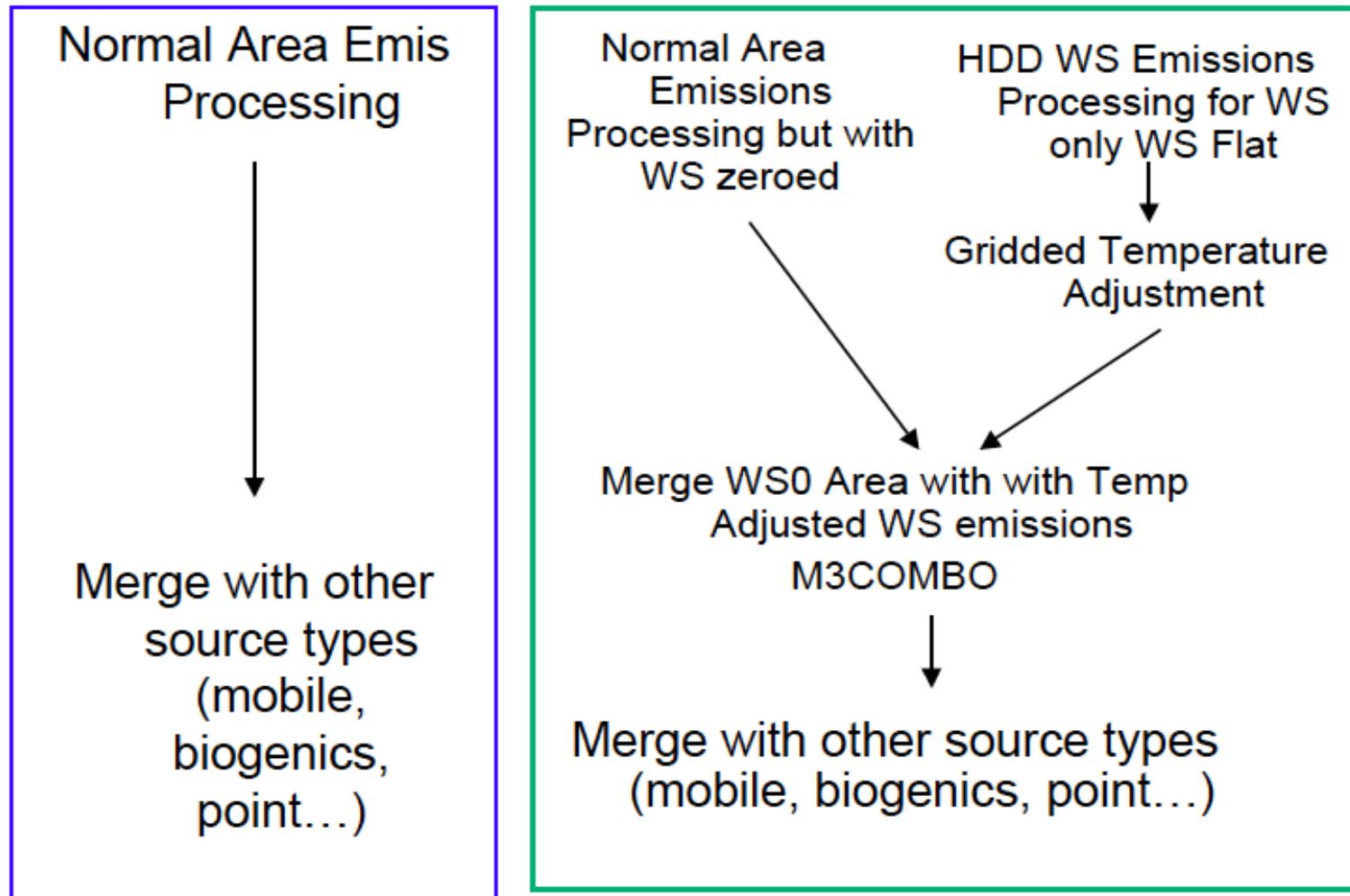

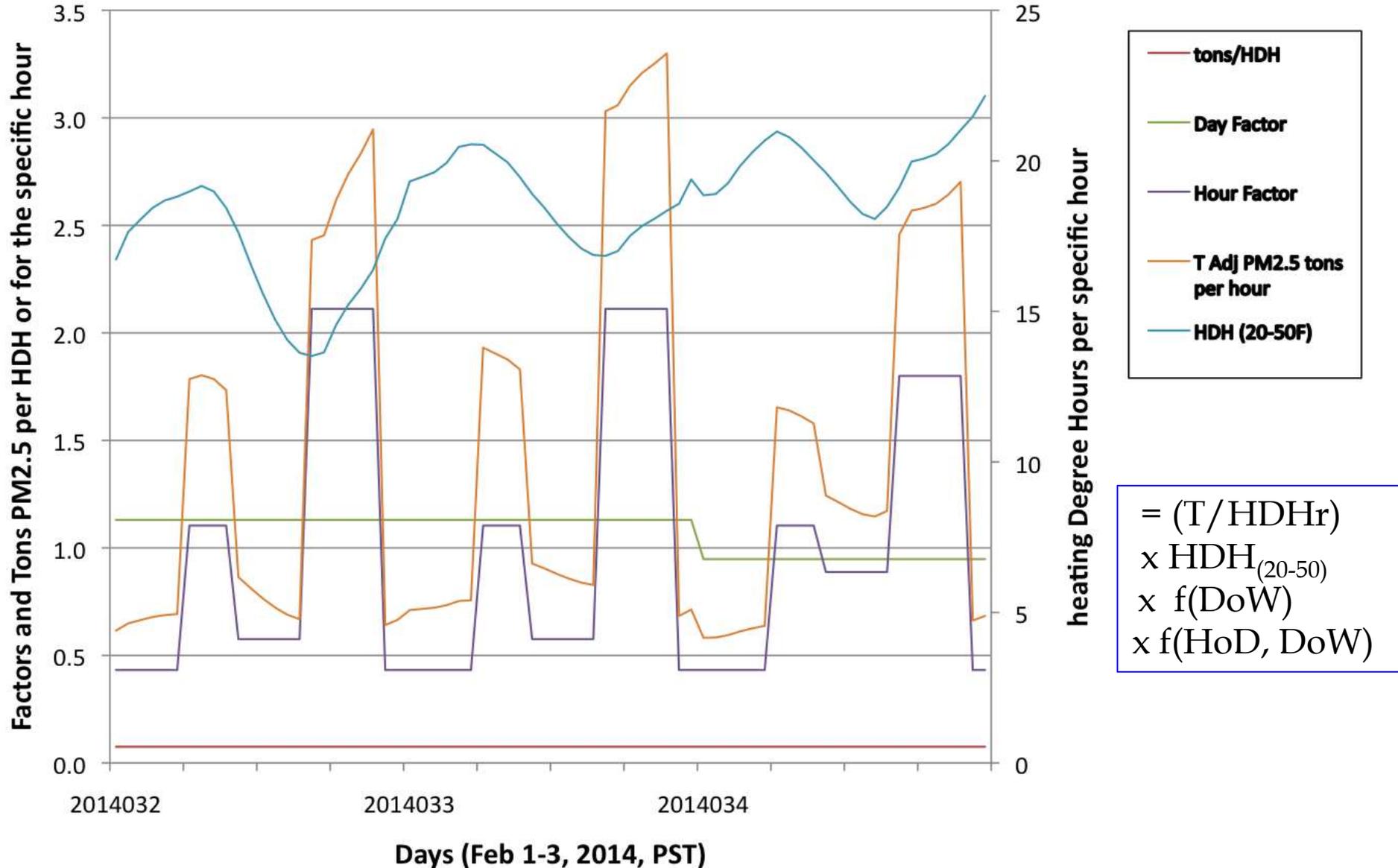
Data flow for applying wood stove emissions temp-adjustment

Prototype WS Emission as $f(\text{Temp})$

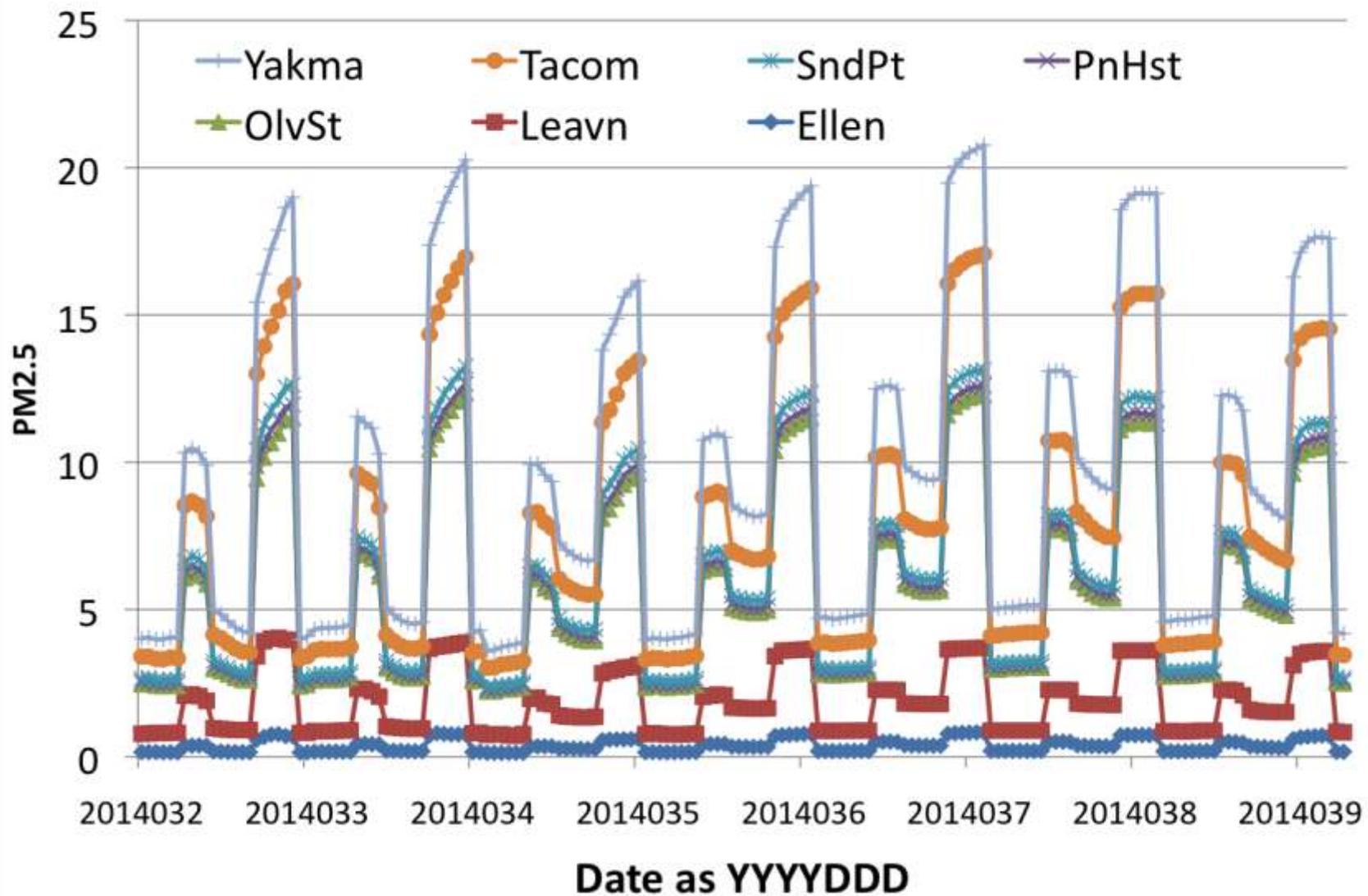


Temperature Adjustment Debugging Output for Cell containing Yakima, WA

Feb 1 - 3 at Yakima for WSTA14



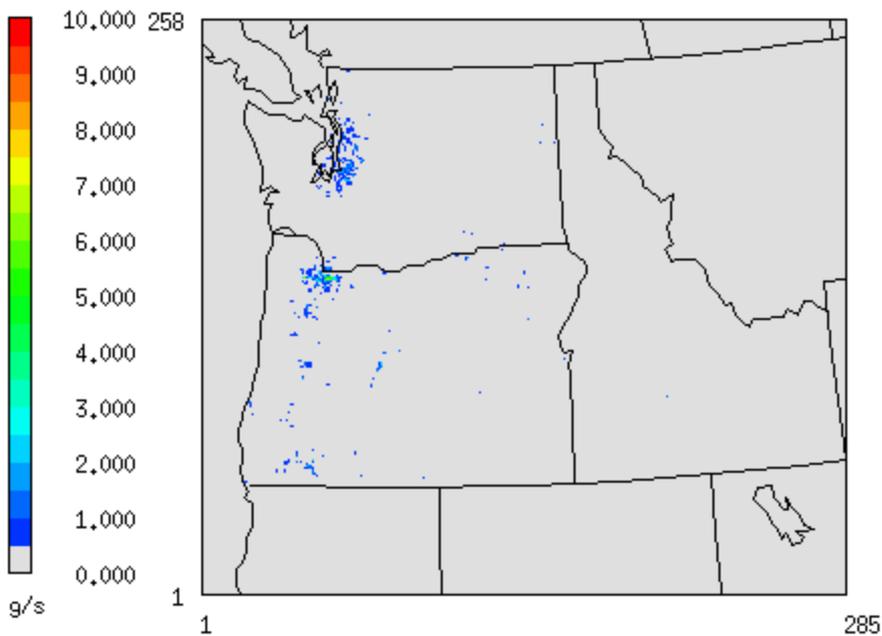
Hourly PM2.5 [g/s] Feb 1-7, 2014, Seven Sites

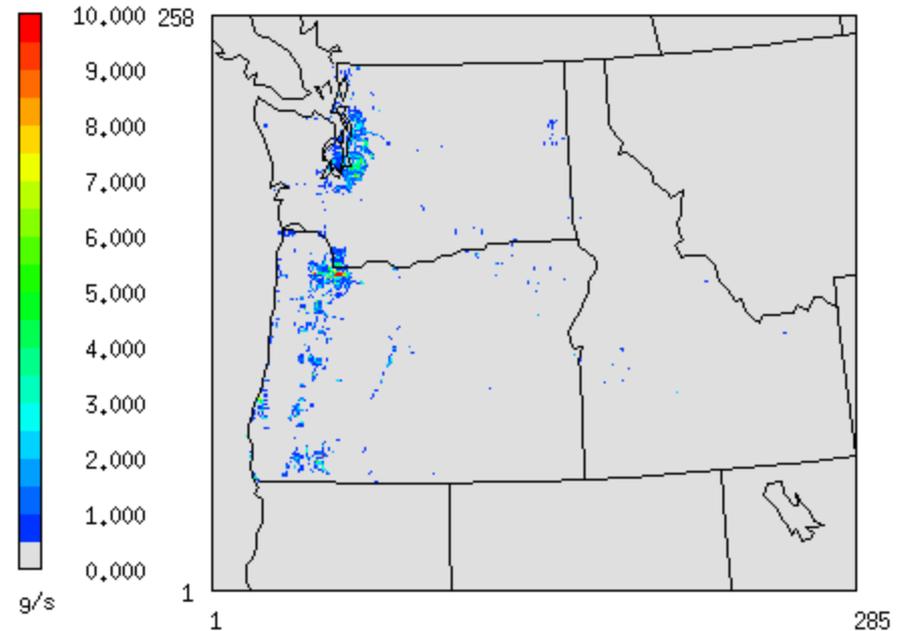

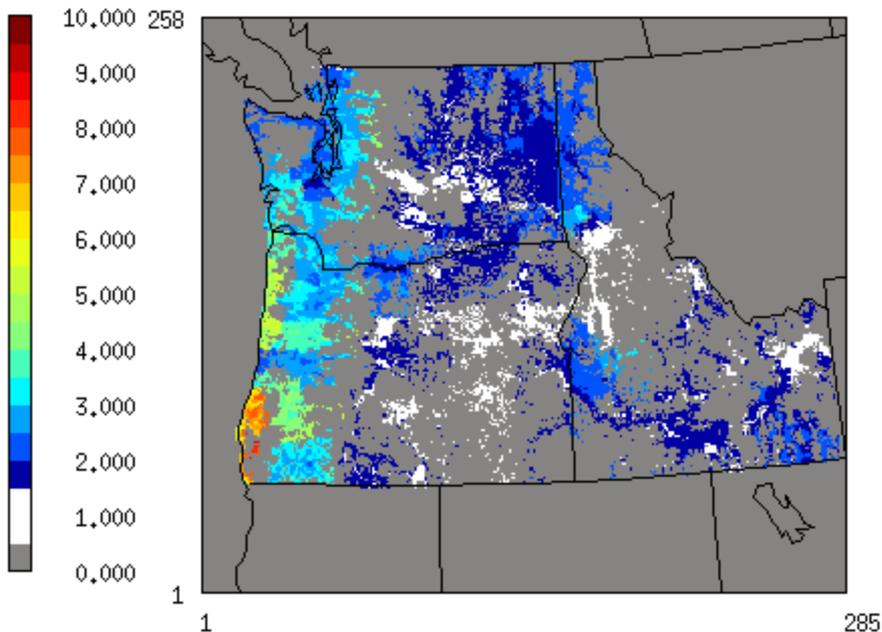

Ratio of Wood Smoke PM_{2.5}

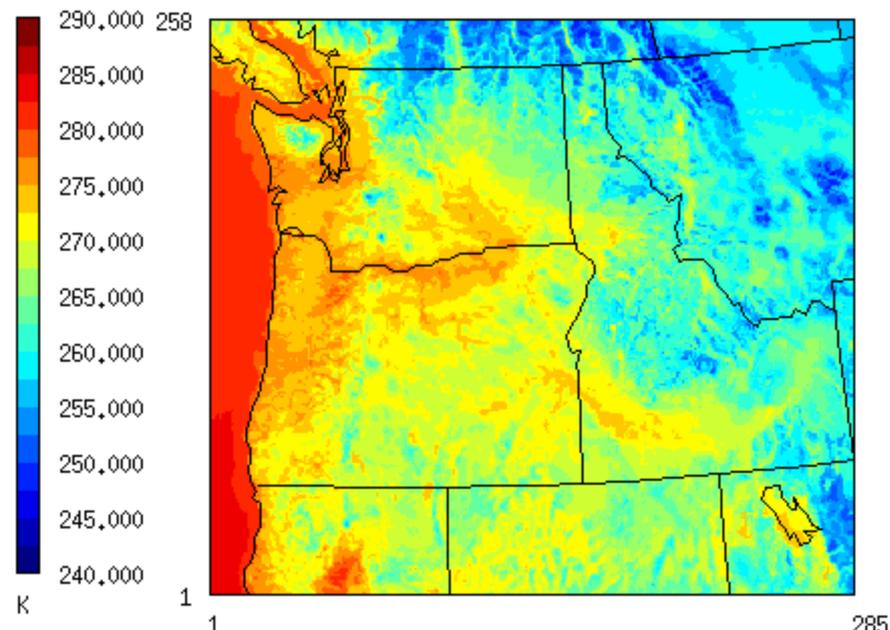

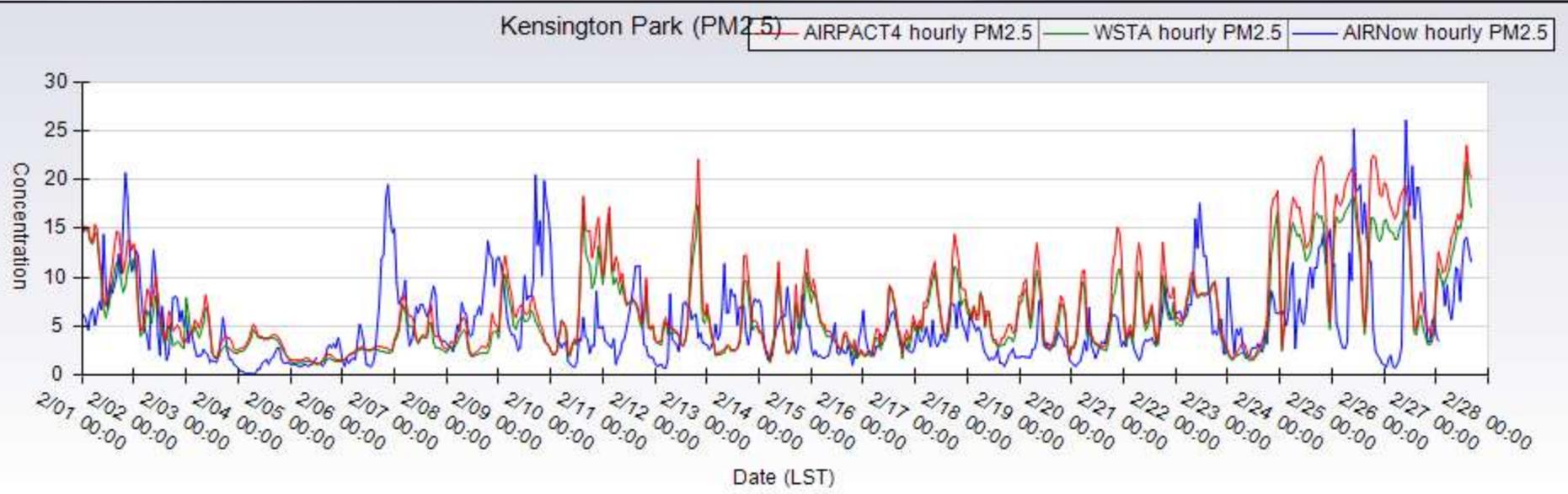

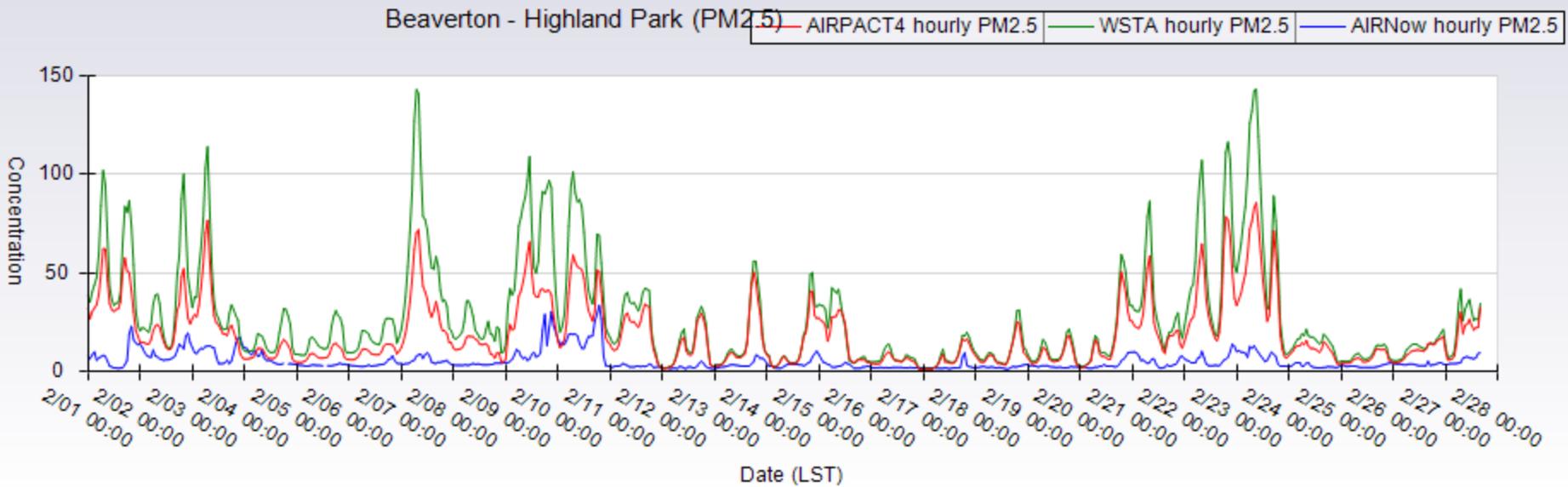

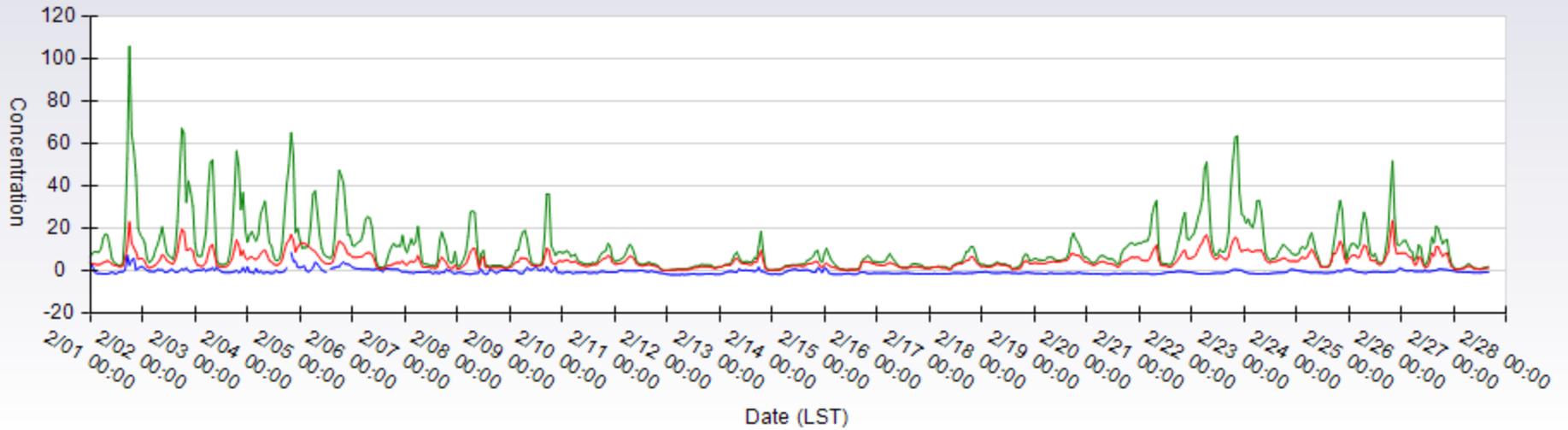

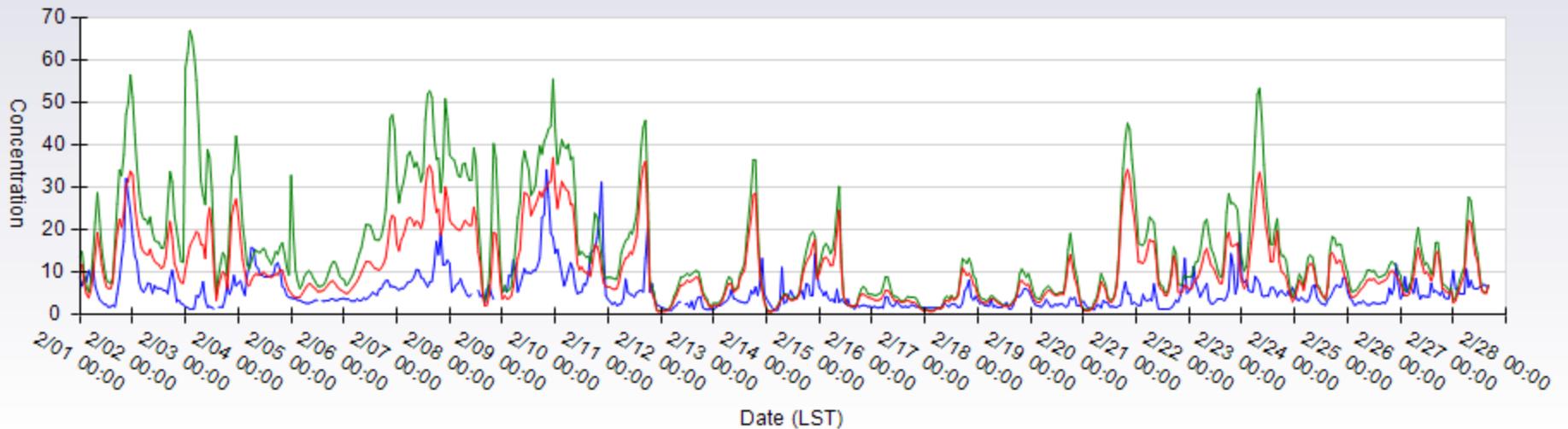

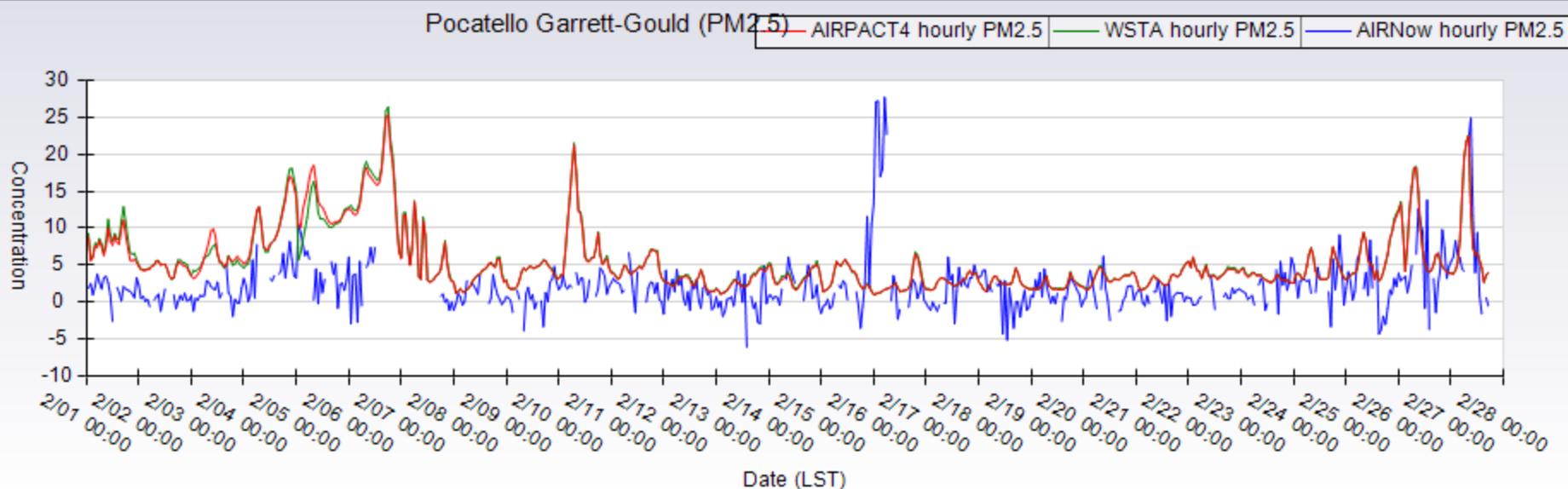

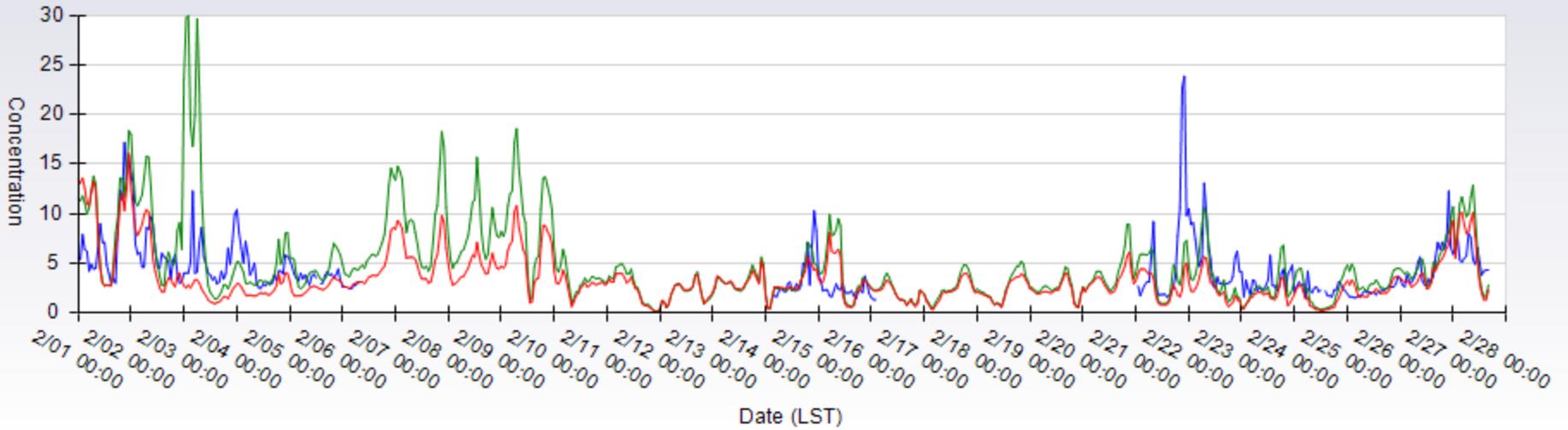

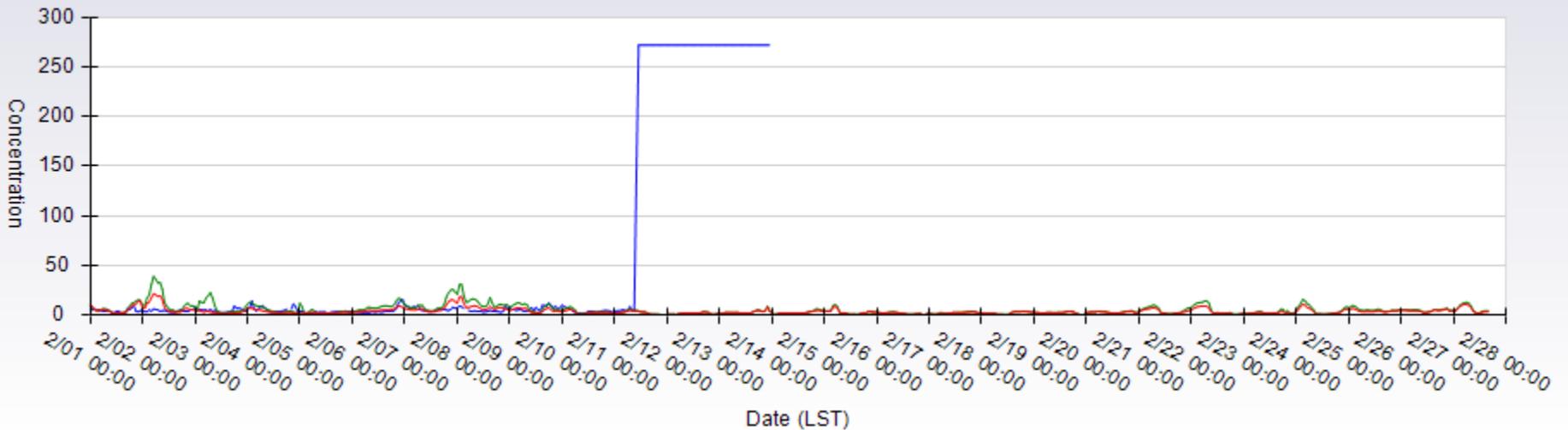

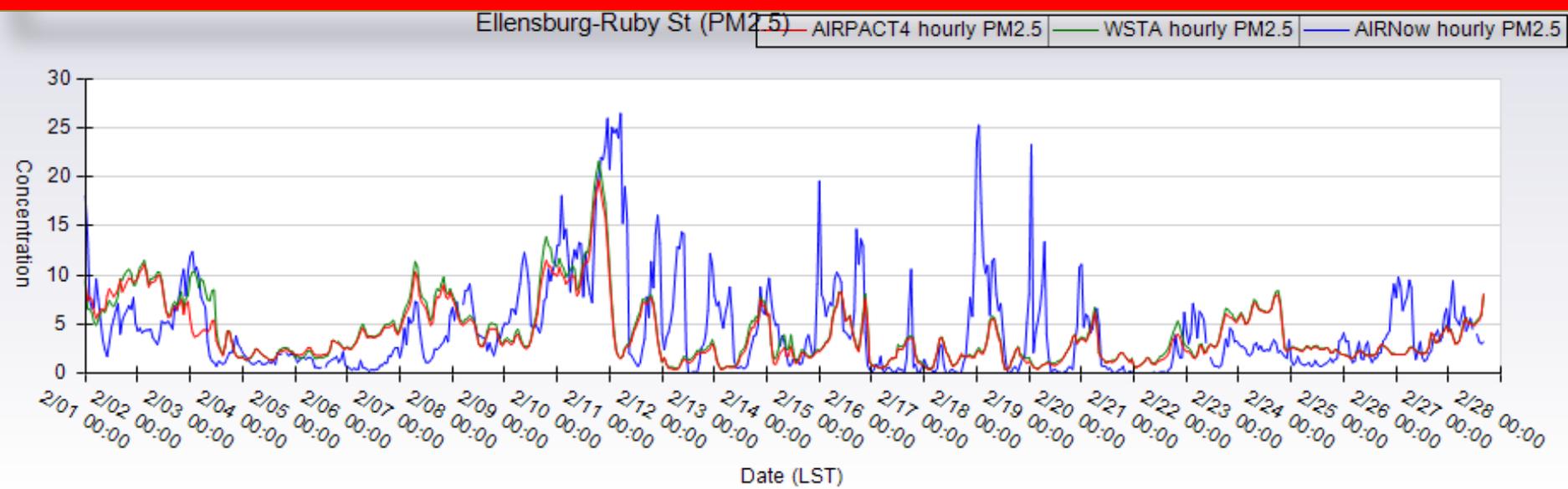

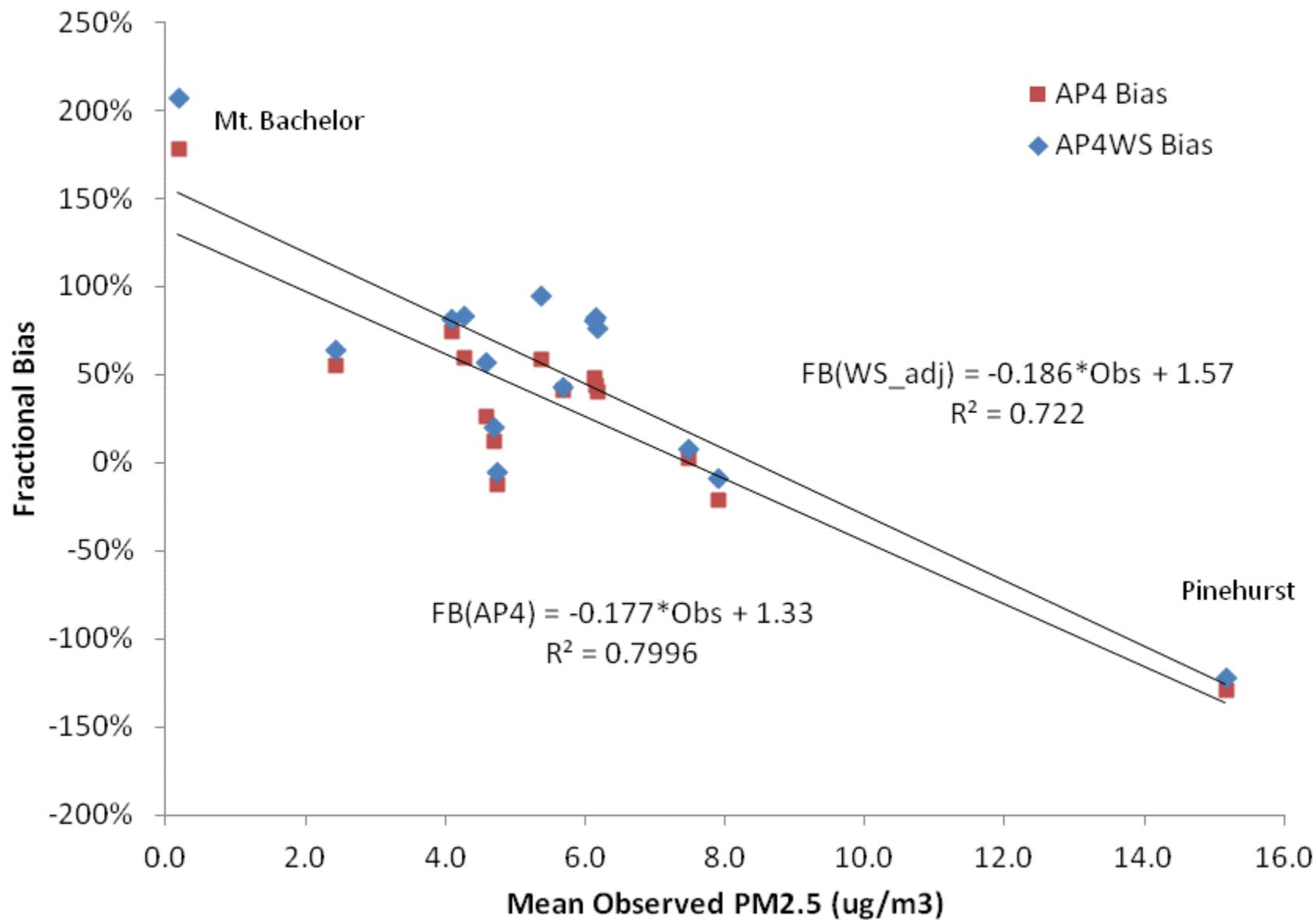

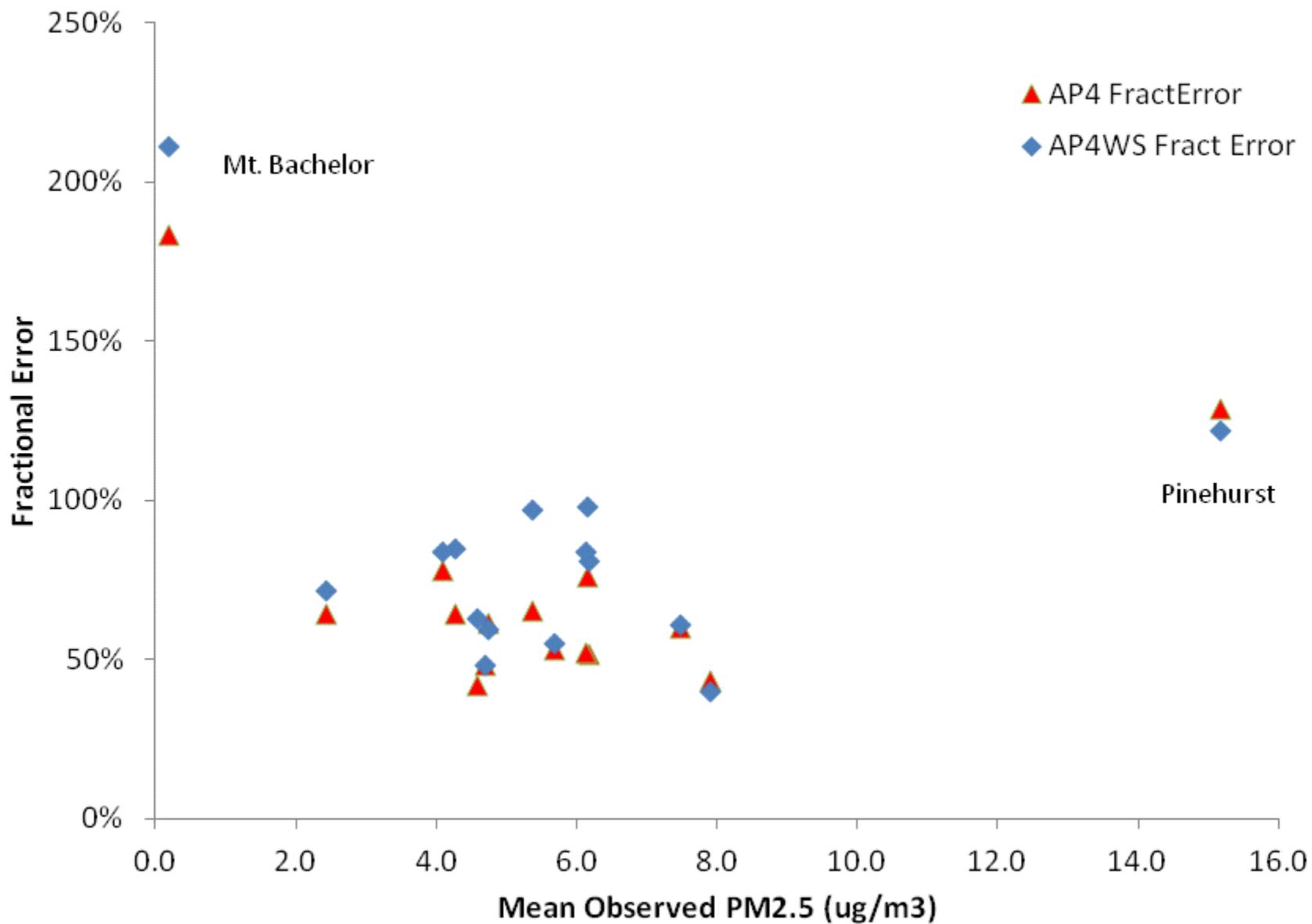
